# IMPORTANT - WHEN TO USE THIS FORM

**Amend an Existing Owner Builder permit** if you have forgotten to include work in the original permit or if there are changes to the plan before or during the construction. This application is not required for minor changes that will not affect your Owner Builder permit description of work.

#### 🖌 What can be amended

You can add to or make changes to the **description of** work provided in the Owner Builder permit approval if no additional work has commenced.

You must wait until you receive the amended permit before starting any additional work. Please allow 10–15 working days for your application to be processed.

# 🗙 What can not be amended

- The permit can not be transferred to a different site.
- The expiry date can not be extended.
- The notification of the permit on the title can not be removed until 7 years have expired, even if no work has been performed under the permit.

#### ADDITIONAL BUILDING WORK

Have you already started or completed additional building work?

Yes – You can not apply to amend an Owner Builder permit after additional work has commenced. You must submit a Work Already Completed form to request a confirmation letter that no insurance premium is payable (for the purpose of obtaining development approval) from the QBCC.
