The QBCC is collecting information on this form to determine whether you are entitled to an Owner Builder permit. This is authorised by the *Queensland Building and Construction Commission Act 1991* (QBCC Act). Some information collected on this form will be included in the Owner Builder register on the QBCC website. In addition, the QBCC is obligated to notify the Registrar of Titles of the granting of the permit. On receipt of this information, the Registrar of Titles will enter the notification into the land register.

You may receive information from us for educational purposes in accordance with the QBCC Act. We may use your email address to contact you about improving the delivery and effectiveness of our services, including activities such as customer research and engagement. You will be able to opt-out of receiving this information. All information held by the QBCC may be subject to an application for access under the Right to Information and Privacy legislation or as authorised or required by law. PLEASE REVIEW BEFORE YOU COMPLETE THIS NOTICE

Surrender an Owner Builder permit if you:

- · choose not to do any work before or after obtaining building approval and starting work under the permit
- · decide to enter into a contract with a licensed builder to carry out the work described in your Owner Builder permit.

You may surrender your Owner Builder permit by completing and submitting the notice to surrender a permit form and returning the permit. This notice must be completed and signed by all permit holders under the Owner Builder permit.

If you surrender your permit, **the Owner Builder administrative notation will still remain on your property title for 7 years** in accordance with legislation. Once the 7 years have expired, you can ask Titles Queensland to remove the notation from your title. The QBCC can not do that for you.

Returning your Owner Builder permit

You will need to provide the QBCC with either the hardcopy Owner Builder permit or a copy of the electronic Owner Builder permit when you give notice to surrender your permit. If you cannot provide the QBCC with either you MUST complete a request for a replacement Owner Builder permit BEFORE submitting this surrender permit notice.
