The Acts Interpretation (Fee Unit) Amendment Regulation 2023 (the Regulation) was made on 11 May 2023 and commences 1 July 2023. The Regulation prescribes the value of a fee unit for a given Act pursuant to section 48B of the Acts Interpretation Act 1954 and provides for the indexation of the fee unit value for this financial year.

Information for Applicants

The following information provides assistance for Applicants applying to be registered by the Adjudication Registrar, as an Adjudicator under section 159 of the Building Industry Fairness (Security of Payment) Act 2017 (the Act).

You will need to supply the following:

- A certified copy of driver's licence or passport.
- 3 referees who can attest to your experience which is relevant to deciding adjudication applications.
- Certified copies of all qualifications listed in the application.

Under Section 159(2) of the Act, this application form must be signed by or for the Applicant; and be accompanied by the fee of \$894.06 as prescribed under the Building Industry Fairness (Security of Payment) Regulation 2018.

If application is accepted

- Registration will become effective in accordance with Section 164 of the Act.
- It is a condition of registration that Adjudicator's comply with the Act and any other conditions of
- registration imposed under Section 165 of the Act.
- Continued registration is dependent on such compliance.
- Under Section 170 of the Act, a registrant who contravenes a condition of registration is liable to have their registration suspended or cancelled
